
## New *Milk* Regulations

Parents who send in any milk for your child:  
Please be aware that once the carton is opened;  
we can only serve the milk to your child(ren) for  
up to 7 days, regardless of the expiration date  
that appears on the carton. You are welcome to  
take the opened carton home after 7 days has  
passed, or feel free to send the milk in a sippy  
cup. This is a state law we are required to com-  
ply with. We apologize for the inconvenience  
and thank you in advance for your cooperation!



## *REGARDING DROP-OFF TIMES FOR CHILDREN*

*If you have a change of time for dropping off your child(ren) please make sure we are aware of the change a week in advance. ## Change of seasons = *cold weather gear*

Please re-check the clothing in your child's classroom cubby. Make sure there are warm shirts, long pants, extra socks, extra shoes and extra underpants (in case of accidents).

Also, now is the time to send in appropriate outdoor wear — mittens, hats, snow pants, boots and warm winter coats are needed for playing outside, especially on snowy days. We plan to go outside every day, unless the temperature (and/or wind chill) drops below 25 degrees.

Please label all of your child's clothing, especially the outer wear. It's easy to mix up and lose little mittens, hats, coats, boots and snowpants.
